CHECK YOUR VOTER REGISTRATION - DEADLINE IS OCTOBER 29TH

- Are you already registered to vote in Massachusetts? Check the website below to confirm whether you are registered and where you are registered.

- If you are **not** already registered or you need to change your address and you have a valid Massachusetts Driver's License or ID Card, you can register to vote online. You must be a U.S. citizen and at least 18 years old on October 29, 2022

Vote Early By Mail



- Send your Vote by Mail application to the Town Clerk by 5 PM, November 1st. Be sure to sign the application, OR write and sign a note with the following information: Name, Belmont address where you live, your mailing address (if different). Please note: the Post Office will not forward ballots.
- Mail the application to Belmont Town Clerk at 455 Concord Avenue, Belmont, MA 02478, or drop into our secure Dropbox at Town Hall
- **A voter should submit only one request/application for a Vote by Mail ballot**
- Check the status of your application and ballot by visiting: www.VoteInMA.com use "Track my mail in ballot" "Pending" means we have received your application.
- **VOTE YOUR BALLOT RIGHT AWAY!**
- Sign the inner envelope and mail to Town Clerk 455 Concord Avenue, Belmont, MA 02478 or drop into our secure Dropbox at Town Hall.

Vote Early In Person



- Only at Belmont Town Hall, 455 Concord Avenue
- *No advance application is required*
- If you intend to Vote Early In Person, please do not file a Vote By Mail application
- Dates: Saturday October 22nd through Friday, November 4th
(See schedule of dates and times below)
- Saturdays October 22 and 29 10 AM – 4 PM
- Mondays October 24 and 31 8 AM – 7 PM
- Tuesdays October 25 and Nov. 1 8 AM – 4 PM
- Wednesdays October 26 and Nov. 2 8 AM – 4 PM
- Thursdays October 27 and Nov. 3 8 AM – 4 PM
- Fridays October 28 and Nov. 4 8 AM – NOON
- **EARLY VOTING ENDS AT NOON ON FRIDAY, NOVEMBER 4, 2022**

Vote In Person on Election Day, November 8th 7 AM to 8 PM
